

33rd Annual Bishop's Pro-Life Dinner Raffle

February 21, 2026

Terms and Conditions

The following are the terms and conditions of the "33rd Annual Bishop's Pro-Life Dinner Raffle" which is sponsored and managed by The Catholic Pro-Life Community (CPLC).

Your participation in the Raffle shall be deemed to be your complete acceptance of the terms and conditions herein.

1. Entry to the Raffle is available only to persons over the age of 18. You may be asked, at any stage, to provide the CPLC or a third party with proof of age and/or identity.
2. The CPLC's Officers and CPLC staff and volunteers directly responsible for conducting the Raffle shall not be eligible to enter the Raffle.
3. In order to enter the Raffle each entrant must purchase (or have purchased for him or her) at least one Raffle ticket, at a cost of \$50 per single ticket, \$150 per four tickets or \$200 per six tickets. The winner of the Raffle is the person named on the ticket that is drawn.
4. To submit your entry:
 - (a) Internet Access the CPLC website at www.prolifedallas.org and/or navigate to <https://muradbid.com/cplc/raffle> ("Raffle Website"), and complete the Raffle Entry Form by providing all requested information and then clicking "Submit." When payment is received, the ticket(s) will be filled out with your information and entered into the raffle.
 - (b) In Person: Purchase your raffle ticket(s) in person from an authorized CPLC volunteer via electronic purchase. Tickets are available for purchase at the CPLC office, 17177 Preston Road, Suite 310, Dallas, TX 75248, during office hours, 9 a.m. to 5 p.m. Tickets are also available through local chapters of the Knights of Columbus, Respect Life Ministry Leaders, other authorized volunteers, and volunteers at the Bishop's Pro-Life Dinner on February 21, 2026, at the Renaissance Dallas Addison Hotel.
 - (a) Phone: Purchase your ticket(s) over the telephone at 972-267-LIFE (5433) from an authorized CPLC staff member or volunteer by providing entry and payment information. The ticket(s) will be filled out with your information and included in the Raffle.
5. Prize(s) for winning the Raffle shall be:

1st Prize – Winner's Choice of trip: a three-night stay for two on a Napa Train Winery Tour, a four-night stay for four at Disney World, or a five-night stay for two inside the Vatican. \$1000 toward airfare included.

2nd Prize – \$2,500 in grocery gift cards and a \$500 gas card.

3rd Prize – Brunello Cucinelli Italian leather bag valued at \$1,600.

*Taxes are the sole responsibility of the winner. CPLC will furnish the tax documents required for the IRS.

6. The CPLC shall cease accepting Raffle entries on February 21, 2026, by 8 p.m.
7. The drawing shall take place at the 33rd Annual Bishop's Pro-Life Dinner at the Renaissance Dallas Addison Hotel on February 21, 2026, in this order:
 1. 1st Prize (ticket to be set aside for announcement at the end)
 2. 2nd Prize
 3. 3rd Prize
8. The winner of the Raffle Prize(s) need not be present at the drawing in order to win.
9. The Prize(s) shall be issued by the CPLC as soon as is reasonable, but at a date no later than 90 days after the drawing to the winner(s).
10. The CPLC shall notify the winner(s) via certified mail, or by any available method, within ten (10) days following the Raffle. The winner shall be awarded the Prize as noted in Number 7 above.
11. Notwithstanding Section 10 above, in the event that, for any reason whatsoever, the Prize winner(s) fail to respond, within ninety (90) days, to the certified mail notification of his/her winning, such winning entrant(s) shall be deemed to have forfeited his/her claim to such Prize(s) and the CPLC shall not have any obligation whatsoever to compensate the winning entrant in any way. It is at the sole discretion of the CPLC to then conduct a further drawing of ticket(s) from previously sold and retained tickets.
12. The CPLC's decision is final with respect to all matters relating to the awarding of the Prize(s) and shall not be subject to review or appeal by any entrant or by any third party.
13. Your participation in the Raffle is deemed your agreement that the CPLC may use your name, likeness or image for promotional and marketing purposes without the requirement for any payment to you, and you hereby grant the CPLC the right to do the same and expressly waive any claims against the CPLC in this regard.
14. The Prize(s) is neither transferable nor exchangeable and cannot be exchanged for money or money's worth.
15. By entering the Raffle each entrant unreservedly agrees to these terms and conditions which govern the Raffle and the awarding of the Prize(s).
16. By entering the Raffle each entrant agrees to release, discharge and hold harmless the CPLC, its legal representatives, affiliates, subsidiaries, agencies and its respective officers, directors, employees and agents from any damages whatsoever suffered or sustained in connection with the Raffle or the acceptance of the Prize(s).
17. The winning entrant shall be solely responsible for any taxes levied in relation to the delivery or receipt of the Prize(s).
18. The CPLC reserves the right to alter these terms and conditions at any time and at its sole discretion.
19. The CPLC reserves the right, at any time, to cancel, modify or suspend the Raffle if, in its sole judgment, the Raffle is not capable of being conducted as specified.
